# REVIEW AND APPROVAL OF NEW EMPLOYEE HANDBOOK

The District has been trying to get a new employee handbook completed for many years. Assistant Manager Burns was able to complete the handbook, and it was sent to our attorney's office for review. The document review was completed, and copies of the draft handbook were given to the Board for their review immediately following the May 6<sup>th</sup> board meeting. To implement the handbook without further delay the Board asked to hold this meeting to adopt the new handbook.

The Board thought the handbook was well written and covered the necessary policies of the District. Following a brief discussion, a motion was made by Director Bohn and seconded by Director Hogan to approve the new Employee Handbook as presented. President Winters, Vice President Hogan and Director Bohn each voted in favor of the motion.

## REVIEW MEDICAL AND DENTAL INSURANCE RENEWAL

Manager Derry stated that our local insurance agent requested bids for the renewal of insurance from various companies. Following a lengthy discussion, it was the decision of the Board, in a motion made by Director Bohn and seconded by Vice President Hogan, to stay with the current insurance through Regence. The renewal amount is within budget of what the District allowed this year. President Winters, Vice President Hogan and Director Bohn each voted in favor of the motion.

The District does not currently have a policy regarding the audio recording of board meetings. The official minutes of all board meetings have always been written and approved and signed by the Board at the next regular board meeting. ORS 192.610 authorizes "the minutes to either be recorded or written". A motion was made by Director Bohn and seconded by Vice President Hogan to no longer record the board meetings, since the official records of the meetings are the written minutes signed by the Board each month. President Winters, Vice President Hogan and Director Bohn each voted in favor of the motion.
